ERBUD will build a service and apartment complex in Międzyzdroje

On 30 April 2010 Erbud signed a contract for construction of service and residential complex in Międzyzdroje. The contract, to be performed from May 2010 to March 2011, is worth PLN 18.1 million. Międzyzdrojski Rynek Sp. z o. o. is the investor and customer.

Erbud S.A. will construct an apartment complex with services in Międzyzdroje. The commencement of work is planned for May 2010 and completion - in September 2011. The net contract value amounts to PLN 18.1 m.

This is the fifth Group's contract in the large-volume building segment signed in April this year. The total value of contracts from the above said sector concluded by the Group in April amounted to more than PLN 100 million net. During the past four weeks the Erbud Group has concluded two housing contracts (residential complex in Bielany and housing area in Ursus), a contract to build the „Galeria Twierdza Zamość” Shopping Mall and another one for the reconstruction of laundry in the Silesian Medical University.

The total portfolio of Erbud's Group orders at the end of April for the years 2010 - 2011 amounted to over PLN 1 billion net.
